ELIGIBILITY

Open to Artists currently Living in California, Oregon, Washington, and Alaska. Acceptable media include painting, drawing, printmaking, photography, sculpture, and mixed media.

RULES/ENTRY INSTRUCTIONS

- A maximum of one entry with up to three artworks may be submitted.
- If submitting works in different media categories, please indicate your media in your description of work.
- Artwork must be original and completed within the last three years and not previously shown at Turtle Bay.
- Each entry is limited to one digital image for two-dimensional work or two digital images for three-dimensional work.
- A non-refundable \$40 registration fee covers up to three artworks.
- All accepted artwork must be available for exhibition and remain at Turtle Bay during the entire exhibition period.
- All accepted artwork must be labeled legibly on the back or base with:
- Artist's Name, Title, Medium, and Date
- Two-dimensional artwork must be framed with hanging wire or otherwise be ready to hang. Artwork with colored mats and/or under glass without a rigid frame will not be accepted.
- Dimensions must be indicated in inches. The maximum allowable height of artwork is 11'. All artwork must be able to pass through a 96"h X 64"w door opening.

INSURANCE

All artwork will be insured against physical loss or damage while in the possession of Turtle Bay.

TERMS OF ENTRY FOR ENTRANTS

If my artwork is accepted, I agree to deliver my work January 20-23, 2023 or ship my work to Turtle Bay Exploration Park (TBEP) for arrival by January 23, 2023. I understand that if accepted, this artwork will be insured while at TBEP from its arrival at the museum until its release to the artist, his/her agent, or shipper. I agree to furnish TBEP with an insurance value. I agree that recovery shall be limited to such amount as may be paid by the insurer, hereby releasing TBEP, its trustees, officers, agents, and employees from liability from any and all claims arising out of such loss or damage. TBEP shall have the right to photograph, telecast, and/or reproduce my artwork in full or in detail for educational, catalog, or publicity purposes including on Turtle Bay's website. If my piece is for sale, I agree to furnish TBEP with a sale price and understand that TBEP takes a 25% commission on pieces sold during the exhibition.
